- Written notice advising of the board's decision on each application will be forwarded to all applicants. If an application has been accepted for membership, the Secretary shall, as well as forwarding written notice, request payment of the first annual subscription.
- Upon payment of the first annual subscription, the applicant shall become a member of the Company, provided nevertheless that if such payment be not made within two (2) calendar months after the date of the notice, the Board may in its discretion cancel its acceptance of the applicant for membership of the Company.
